IN FISCAL YEAR 2008, MACED AND ITS AFFILIATED NONPROFIT APPALACHIAN INVESTMENT CORPORATION MADE 48 LOANS TO SMALL BUSINESSES FOR A TOTAL OF \$2,910,711 INVESTED IN ITS SERVICE REGION. OF THESE LOANS, 23 WERE MICROLOANS. TECHNICAL ASSISTANCE WAS PROVIDED TO 260 BUSINESSES.
